RE: Exterminator Licence Application

Your new Exterminator Licence authorizes you to perform pesticides exterminations of the type and class specified on the licence and is subject to the requirements of the Pesticides Act and regulations. When conducting an extermination, you must have your Exterminator Licence (or a legible copy) readily available at the extermination site.

Under the Pesticides Act and Ontario Regulation 63/09, an Operator Licence is required to operate an extermination business in Ontario. If you are charging for your extermination services, you must possess a valid Operator Licence and hold appropriate insurance, or work for someone who does.

If any of the information provided on your Exterminator Licence application changes (such as your address), you must notify the Ministry of the Environment and Climate Change, in writing, within 10 days.



Frequently Asked Questions

How do I renew my licence?

You will receive a notice in the mail 45 days prior to your licence expiry date. This notice will provide you with detailed instructions on how to renew your licence. If you have not received your renewal notice or have questions about the renewal process, please contact the Environmental Assessment and Approvals Branch at the address below.

How do I update my address? / How do I request a new copy of a lost or damaged licence?

If you move or your address changes, you must notify the Ministry of the Environment within 10 days. To update your address, please complete the "Pesticide Licence Information Update Form" available in the publications section of the Ministry of the Environment website at www.ene.gov.on.ca or from the Environmental Assessment and Approvals Branch at the address below. You can use the same form to request a new copy of your licence if it is lost or damaged.

How do I apply for another type of Exterminator Licence?

You must complete an MOE approved course and pass a certification exam for the type and class of licence that you plan to apply for. Information regarding pesticide training and certification is available from Ridgeway Campus, University of Guelph toll free at 1-888-620-9999 or (519) 674-1575. Once you have passed the certification exam, you must complete and submit an "Application for a Pesticide Exterminator Licence", available in the publications section of the Ministry of the Environment website at www.ene.gov.on.ca.

Now that I have a licence, do I also require a permit to apply pesticides?

Before you can apply certain types of pesticides, you must receive a permit issued by the Ministry of the Environment. Examples of pesticide use that may require a permit include:

1. Use of a Class 2 pesticide to fumigate a building, portion of a building, or in a vehicle or structure.
2. Use of a Class 2 pesticide to destroy bees in a structural extermination.
3. Land application of a Class 2, 3 or 4 pesticide that contains picloram.
4. Aerial application of a Class 2 pesticide.
5. Aerial application of a pesticide that contains 2, 4-D, 2, 4DB, mecoprop, MCPA, MCPB, dichlorprop, dicamba, paraquat or triclopyr.
6. Aerial application of a Class 3 or 4 pesticide performed in connection with the management of a crown forest.
7. Applications of pesticides to water.
